## Discovery 2024 Upgrades



And just like that December is upon us and 2023 is winding to a close. In this brief newsletter we want to remind you that the deadline to upgrade your medical aid plan is approaching.

## **Discovery Health Plan**

As you may be aware, members of medical schemes are allowed to upgrade their plans on the 1st January every year. The reason it is only allowed once a year is to prevent anti-selection, where a member takes the lowest plan, until such time as they need treatment, and then briefly upgrading. The Discovery Health cut-off to request an upgrade on 1 January 2024 is **15 December 2023**.
